## **Criteria** Score definitions

IDENTIFY/ Topic Sentence	0	1
The response should begin with a topic sentence that directly addresses all parts of the given prompt: 1.Must IDENTIFY who created the source (the specific type of person, group, or institution that produced this document/image, not just describing the visual content) 2. Must explain what the creator is trying to ARGUE/CONVINCE/DEMONSTRATE (the specific message, claim, or interpretation the author wants the audience to accept) 3. Must connect the argument to a specific historical PERSPECTIVE/POINT OF VIEW (how the creator's background, interests, or circumstances influenced their portrayal of events)	The response does not address the prompt, lacks a clear topic sentence or incorrectly identifies the author.	The response begins with a clear and insightful topic sentence that directly addresses all parts of the prompt and makes a specific analytical argument about the source's historical significance. 1. When the prompt specifies a time period, the response must contextualize the source within that timeframe. 2. Students must state WHO created the source 3. Must explain WHAT argument the creator is making, thereby demonstrating understanding of the author's historical point of view or the purpose of the document.

Must connect that evidence to a relevant broader historical pattern. 3. Must explain the historical significance/relevance of that evidence to the topic.

The response does not provide specific historical evidence. define and connect to the topic sentence. The evidence is incorrect. irrelevant to the prompt, or is from the wrong historical time period. **Important** transition sentence might be missing "for instance" or

The response includes specific and relevant evidence (a historical person, place or event) that effectively supports the topic sentence. Evidence must be defined and connected to the topic that is relevant to the time period and 1. Response may identify specific visual evidence from the source 2. Response may connect that evidence to a relevant broader historical pattern or concept 3. Must explain the historical significance/relevance of that evidence to the topic. Response should include transition phrases like "for instance" or "for example" or "One piece of evidence" in the response.

## EXPLAIN (Analysis)

The response must analyze how the evidence supports the topic sentence and ties back to the prompt or overarching themes. This is accomplished by completing each of these: 1. Identify the author's specific PURPOSE for creating the document/image 2. Explain
